

IRELAND STAPLETON'S COMMUNITY ACTION COMMITTEE ROLLS UP THEIR SLEEVES TO HELP THOSE IN NEED

Denver, CO (August 24, 2011) – Building upon Ireland Stapleton's rich history of community service and supporting local charities, the firm's Community Action Committee (CAC) is proud to share the following update on recent community outreach and volunteer efforts.

In June, the CAC held a Shoebies for Soldiers drive, collecting items to be included in "Care Packages" for a group of U.S. Army soldiers stationed at Duke Field, Florida. The two-week drive resulted in 26 boxes filled with non-perishable goods, personal hygiene products, and books – all of which were received with gratitude by the soldiers on July 7.

Also in June, the CAC organized a Habitat for Humanity "Build Day." On Saturday, June 25, a team of 10 attorneys, staff, family and friends rolled up their sleeves at a Habitat Build Site in West Denver. The group helped with exterior painting and other efforts that resulted in major progress towards the completion of the duplex home. On August 16, a group of

representatives from the firm – including some of the individuals who participated in the Build Day – attended the official dedication of the home to the family who will be living there full time.

During the month of July, the CAC hosted a School Supply Drive benefiting Denver Public Schools and Children's Outreach Project. The entire firm stepped up and the committee was able to donate a number of items including backpacks, pens, pencils, paper and other supplies to help children in need.

And finally, in late August, members of the CAC, as well as other firm representatives, supported the 2011 ERACE Homelessness event. The 5k run/2k Funwalk in Denver's Washington Park raised significant funds for [Senior Support Services](#), a nonprofit day-shelter and soup kitchen for hungry and homeless seniors. 24 firm representatives including staff, attorneys and family and friends either ran/walked or participated in the "sleep-in" fundraising option on Sunday, August 28. Overall, the firm's support raised \$2,075 for the event. In addition, Senior Support Services recognized Ireland Stapleton for receiving the most pledges for the event, and presented
